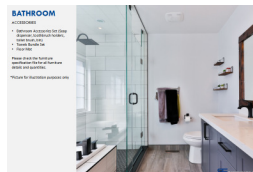
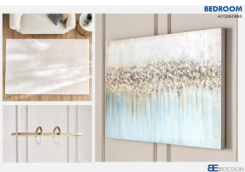

- Site conditions must be clean and ready to receive furniture installation. Any delays or additional costs incurred due to inadequate site preparation shall be the responsibility of the Client.
- The price quoted by BE4 Design is based on the quantity provided and is applicable for the entire order only.
- All local purchases require 100% advance payment upon order confirmation.
- BE4 Design retains the right to refrain from delivery if payment terms are not adhered to.
- Title to all goods shall remain the property of BE4 Design until paid in full by the Client.
- Any changes or modifications requested by the Client after the issuance of a purchase order shall be considered as a variation. BE4 Design reserves the right to adjust the scope, timeline, and pricing accordingly.
